1. AGE AND EDUCATIONAL QUALIFICATION :

(i) The candidate must not be above 30 years of age as on **15.03.2017**. However, the upper age limit is relaxable in accordance with the orders issued by the Govt. of Arunachal Pradesh from time to time, i.e, 35 years for ST/SC candidates and another 5 years relaxable for the candidates serving under Govt. of Arunachal Pradesh.

(ii) Good academic record as defined by the concerned university with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) at the Masters Degree Level in a relevant subject from an Indian University, or an equivalent Degree from an accredited foreign University. However, there is a relaxation of 5% marks that is from 55% to 50% marks at the Masters Degree Level for the ST/SC candidates.

Besides fulfilling the above qualifications, the candidate must have cleared the NET conducted by the UGC, CSIR or similar test accredited by the UGC like SLET/SET.

Notwithstanding anything contained in sub-clauses (i) and (ii) above, candidate who are or have awarded a Ph.D. Degree in accordance with the University Grants Commission Minimum Standards and procedure for Award of Ph.D. Regulations 2009, shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent position in Universities/Colleges/Institutions.

2. <u>METHOD OF SELECTION:</u> The eligible candidates will have to appear in an Interview/Viva-Voce test to be conducted by the Commission at Itanagar or any other place, which may be decided by the Commission. The final selection of the candidates will be made on the basis of the candidate's performance in the Interview/Viva-Voce purely on merit.

Note: The Commission will adopt Recruitment Test (Objective Type) before the interview/ Vivavoce of it is deemed necessary to do so.
