**ADDENDUM**

With reference to advertisement No. PSC-R(B)/03/2018 dated 7<sup>th</sup> June/2018 for the post of PGT & TGT, it is to inform aspiring candidate that the Commission has perused office Memorandum, No. 14015/1/76-Estt-(D) dated 04/08/1980 from the department of Personnel & Administrative Reforms, Govt. of India, and Office Memorandum No. OM-13/2000 dated 14/05/2001 & letter No. AR-123/2014 dated 02/01/2015, from the department of Personnel, Administrative Reforms, Govt. of Arunachal Pradesh. From perusal of above mentioned orders, it is seen that concerned department can hold back vacancies reserved for Meritorious Sports Persons and it is also seen that as per the existing scheme, no written competitive test is taken for filling up of such post. Instead, applicants are required to submit testimonials for their participation as well as winning of medals in qualifying competitive events for consideration against vacancies reserved for sportpersons.

In the light of points stated above, the Commission has excluded the following number of post of PGT & TGT reserved for Meritorious Sport Persons from the Commission's advertisement No. PSC-R(B)/03/2018 dated 7<sup>th</sup> June/2018.


