ADVERTISEMENT.

Applications are invited from citizens of India for filling up of 6(six) posts of Horticulture Development Officer, Group-A (Non-Ministerial) under the Department of Horticulture, Govt. of Arunachal Pradesh in the scale of PB-3 Rs.15600-39100/- Grade Pay Rs. 5400/- PM plus other allowances as admissible to Arunachal Pradesh Govt. employees from time to time. Out of 6(six) posts, 5(five) posts are reserved for Arunachal Pradesh Scheduled Tribe candidates and 1(one) post is un-reserved (open competition). However, the vacancy position is subject to variation.

1. Educational Qualification: The candidates must be B.Sc. (Horticulture) Degree holder from a recognized University or Institution. However, final year students of B.Sc. Horticulture shall also be eligible to apply, provided that such candidates are required to submit Bonafide Certificate testifying their being in Final Year of the course/last semester mark-sheet issued by the University. Such, candidates who are declared to have qualified by the Commission in the written competitive examination will have to produce original certificates or mark-sheets of passing their degree examination to the Commission. The original certificates or mark-sheet of passing their degree examination issued by the Assistant Registrar/Registrar/Controller of Examination/Vice Chancellor of the concerned University will only be accepted by the Commission on or before the date of Interview/Viva-voce. Without the original certificate/mark-sheet they shall not be allowed to appear in the Viva-voce.

2. Age: Candidates must have attained 18 years of age and should not be more than 30 years as on **13.11.2017**. However, the upper age limit shall be relax-able by 5 years for APST candidates and Arunachal Pradesh regular Govt. employees in accordance with the instructions issued by the Government of Arunachal Pradesh from time to time.

3. Method of Selection: The eligible candidate will have to appear in a written examination in the following subjects followed by Viva-voce/Interview to be conducted by the Arunachal Pradesh Public Service Commission at Itanagar on the basis of which selection will be finalized.

(i) General Knowledge	- 100 marks
(ii) General English	- 100 marks
(iii) Horticulture Science (i) Paper – I	- 100 marks
(ii) Paper – II	- 100 marks
(iv) Viva-voce	- 50 marks
Total = 450 marks	

The number of candidates who shall be called for personality test/Viva-voce/interview will be in the ratio of 1 : 3 i.e. 3 candidate for one post as per merit in written examination subject to securing a minimum of 33% or more marks in each written paper and 45% or more marks in aggregate out of the total marks in the written examination.

NOTE: Commission will adopt Recruitment Test (Objective type) before the written examination if it is deemed necessary to do so.

4. **Availability of application form and syllabus:** Application form and Attendance sheet along with syllabus are to be downloaded from the Commission's **Website www.appsc.gov.in**

5. **FEE:** Rs.100 for APST candidates and Rs.150 for others in the form of DD/IPO in favour of Secretary, APPSC, Itanagar, Arunachal Pradesh.

6. **How to apply.**

Along with the dully filled-up application form with attendance-sheet, candidate must enclose the following self-attested documents; other-wise the application will be rejected.

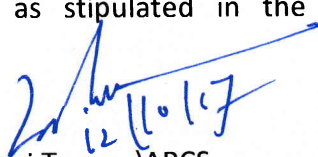
- (i) Self-attested copies of certificates and mark-sheets issued by the Assistant Registrar/Registrar/Controller of Examination/Vice-Chancellor of the concerned University to ascertain educational qualification.
- (ii) Final year candidate must enclose self-attested **Bonafide Certificate** issued by the Institute/University concerned.
- (iii) 2 (two) copies of recent pass-port size photographs with self-attestation in the front side of which one photograph should be pasted on the space provided in the application form and another on the Attendance sheet.
- (iii) Self-attested copy of APST certificate for APST candidates and EPIC/Aadhaar Card for others.
- (v) Self-attested copy of Matriculation Certificate for proof of age issued by the Board only will be accepted.
- (vi) Enclose original copy of DD/IPO of Rs.100/- for APST candidates and Rs.150/- for others.
- (vii) NoC/Intimation letter (self-attested) for those who are in regular Govt service.

7. **Last date of receipt of application.**

The last date for receiving of application form by the Commission is up to **13.11.2017 at 4 PM.**

8. **Other Rules.**

- (i) The decision of the Commission as to the eligibility or other-wise of a candidate for admission to the interview or selection will be final and no correspondence or personal enquiry will be entertained.
- (ii) Candidates already in service may apply direct to this Commission with intimation to his/her present employer for doing so.
- (iii) Application in prescribed form along with necessary documents should be submitted in the Reception counter in a cover/envelope super-scribed, "**Application for the post of Horticulture Development Officer**" and obtain receipt from the counter to ensure his/her submission of application form.
- (iv) The Commission will not be responsible for delay in receipt of application due to any reason whatsoever.
- (v) Application form can also be sent "To The Secretary, Arunachal Pradesh Public Service Commission, Itanagar-791111 (A.P)" through registered post/Courier and should reach the Commission before 4 P.M. on 13.11.2017.
- (vi) Application form not fulfilling the terms and conditions as stipulated in the advertisement will be rejected.

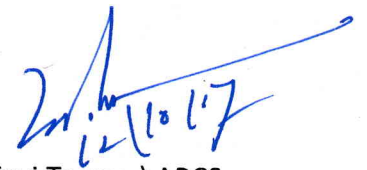
