Applications are invited in prescribed format from the citizens of India for filling up of 6 (Six) posts of Inspector Legal Metrology, Group 'B' (Gazetted) Non-Ministerial, under the Department of Legal Metrology & Consumer Affairs ,Govt. of Arunachal Pradesh in the pay of PB-2 Rs. 9,300-34,800/- +GP Rs. 4,200/- P.M. plus other allowances as admissible to Arunachal Pradesh Govt. employees from time to time. Out of 6(six) posts 5(five) posts are reserved for APST candidates and 1(one) post is unreserved (open competition). Vacancy position and reservation of post is subject to variation.

- 1. <u>AGE</u>: The candidates must have attained 18 years of age and should not be more than 30 years of age as on **08-02-2016**. However the upper age limit is relaxable in accordance with the instructions issued by the Govt. of Arunachal Pradesh from time to time.
- 2. EDUCATIONAL QUALIFICATION: Candidates applying for the post must be a degree in Engineering/Technology in Mechanical /Electrical/Civil/ Electronics & Communication Engineering or B.Sc, with Physics as one of the subjects from a recognized University.

 However the final year students of the Engineering degree courses who are to appear for such final examination shall also be eligible to apply. Such candidates who are declared to have qualified by the Commission in the written competitive examination will have to produce original certificate/Mark-sheets of passing their degree examination issued by the Assistant Registrar/Registrar/Controller of examination/ Vice- Chancellor of the concerned University will only be accepted by the Commission on or before the date of Interview/Viva-Voce. Without the original certificate/Mark sheet they shall not be allowed to appear in the Viva-voce.
- 3. <u>METHOD OF SELECTION:</u> The eligible candidate will have to appear in written examination in the following subjects followed by Viva-voce/Interview to be conducted by the Arunachal Pradesh Public Service commission at Itanagar on the basis of which selection will be finalized.

i) Compulsory paper (a) General English Maximum Marks 100 (b) General Knowledge Maximum Marks 100

ii) One optional paper (Civil Engineering/Mechanical Engineering/Electrical Engineering/ Electronics & Comm.Engineering/Physics)

Maximum Marks 100

iii) Interview/Personality test Maximum Marks 40

Total Marks= 340

The candidate who has secure a minimum of 33% or more marks in each written examination papers and has secured 45% of marks out of aggregate total marks in the written examination paper shall be eligible for Interview/Viva-voce test and on the basis of 1:3 ratio norm.

Note: The Commission will adopt <u>recruitment test</u> (objective type) before the written examination if it is deemed necessary to do so.
