**ADVERTISEMENT**

Applications are invited in prescribed form from the citizens of India for filling-up 23 (twenty three) posts of Assistant Professor in different subjects as per details given below for the Govt. Colleges of Arunachal Pradesh in the Pay Band-3 of Rs.15,600-Rs.39,100 with AGP of Rs.6,000/- per month plus other allowances as admissible to Arunachal Pradesh Govt. employees from time to time. Out of 23 posts, 19 posts are reserved for APST candidates of which 2(two) posts are reserved for PWD candidates. The category of disability for the post is Orthopaedically disabled and 4 posts un-reserved (for open competition). The posts are temporary but likely to be made permanent in due course. Vacancy and reservations are subject to variation.

**1. ELIGIBILITY:** (a) The candidate must not be above 30 years of age as on **04.08.2011** (35 years for SC/ST candidates) and there is upper age relaxation of 5 years for the candidates serving in A.P. State Govt. and other deserving candidates.

(b) Master's Degree in concerned subject with at least 55% marks or its equivalent grade with good academic records. However, there is a relaxation of 5% marks i.e from 55% to 50% at Master's Degree level for the ST/SC candidates and relaxation of 5% (55% to 50%) for the Physically Handicapped candidates..

**2: ESSENTIAL QUALIFICATION:** NET/SLET/SET shall remain the minimum eligibility condition for recruitment and appointment of Assistant Professors in Universities/Colleges/Institutions; *Provided* however, that candidates, who are or have been awarded a Ph.D Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of Ph.D Degree) Regulations,2009, shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions.

**3. METHOD OF SELECTION:** The eligible candidates will have to appear in an Interview/Viva-voce test to be conducted by the Commission at Itanagar or any other place, which may be decided by the Commission. The final selection of the candidates will be made on the basis of the candidate's performance in the Interview/Viva-voce test.

4 **Availability of application form** :- Application form for admission to Interview/Viva-voce test for the recruitment of above post can be obtained from the Commission's office, Itanagar on all working days from 10 Am to 4 Pm up to 04.08.2011 on payment of Rs. 50/- only.

5 **How to Apply**: Along with the duly filled-up format, candidates must enclose the following documents other wise the applications will be rejected.

(i) Treasury Challan of Rs.20/-for APST, and Rs. 80/- for General candidates (Non-refundable) to be deposited in favour of the Secretary, AP PSC, Itanagar to be drawn at Itanagar under Head of Account-0051 PSC. (ii)

2(two) copies of recent pass-port size photographs with self-attestation in the front side.

(iii) Attested copies of certificates and Marksheets right from Class-X onwards up to PG level including P.G. Mark-sheet issued by the Assistant Registrar/Registrar/Controller of Examination/Vice-Chancellor of the concerned University to ascertain educational qualification.

(iv) Attested copy of Matriculation Certificate for proof of age issued by the Board/University only will be accepted.

(v). Attested copy of APST certificate.

(VI). Attested copy of PRC in case of General Candidates.

(vii) All the supporting documents submitted by the candidates including NET/SLET/SET/Ph.D must be attested by a Gazetted Officer with proper designation, name, seal and signature of attesting officer otherwise the application will be rejected.

(viii) Physically Handicapped candidates should submit disability certificate obtained from an authorized Medical Board. But such board should be comprised of a specialist of the particular disability for which the certificate is sought failing which such certificate will be rejected.

**N.B:** The Application form should be procured in the name of the candidate only.

6. **Last date for receipt of application**. The last date for receipt of application form by the Commission is up to 04.08.2011.

7. **Other Rules**:

- (i) The decision of the Commission as to the eligibility or otherwise of a candidate for admission to the Interview or Selection will be final and no correspondence or Personal enquiry will be entertained.
- (ii) Candidates already in service may apply direct to this Commission with a No Objection Certificate from his/her Head of Department.
- (iii) Application in the prescribed form along with necessary documents should reach this Commission in a Cover/Envelope superscribed "Application for the post of Assistant Professor".
