ADVERTISEMENT

Applications in prescribed form are invited from citizens of India for filling up of 5 (five) posts of Assistant Town Planner under the department of Urban Development in the pay of PB 3 Rs. 15600-39100/- plus Grade pay Rs. 5400/- PM plus other allowances as admissible to Arunachal Pradesh Govt. Employees Group 'A' (Non-ministerial). Out of 5(five) posts 4(four) posts are reserved for APST candidates of which 1(one) post is reserved for PWD candidate under the category of One Leg(OL) & Hearing Handicapped(HH) and 1(one) post for open competition. The Vacancy position is subject to variation.

1. Availability of application form

Application form for admission to recruitment examination of the above post can be obtained from the Commission's office, Itanagar on all working days from 10 AM to 4 PM up to 25-03-2011 on payment of Rs. 50/- only.

2. Eligibility

The candidate must have attained 21 years of age and should not be more than 30 years as on 25-3-2011. However, the upper age limit is relaxable by 5 years for SC/ST candidates and A.P. Govt. servants.

3. Educational qualification

Candidate applying for the post must be a Post Graduate Degree/PG Diploma holder in Town Planning, Master Degree in City & Regional Planning, Master in Urban Planning, Master in Regional Planning, Master in Environmental Planning from a recognized University making him eligible for associate membership of Institute of Town Planning(India). Candidate must furnish Registration Certificate from Institute of Town Planning(India) failing which his application will be rejected.

4. Method of Selection

Since the department has no syllabus and it has requested to conduct the recruitment by interview only vide its letter No.DTP/Estt-03/2005-2006/2125 Dated 24th December, 2010 the method of selection will be through Interview/Viva-voce test to be conducted by the Arunachal Pradesh Public Service

Commission at Itanagar on the basis of which selection will be finalized.

5. How to Apply

Along with the duly filled-up format, candidates must enclose the following documents otherwise the applications will be rejected.

(i) Treasury Challan of Rs.20/-for APST, and Rs. 80/- for General candidates (Non-refundable) to be deposited in favour of the Secretary, APPSC, Itanagar to be drawn at Itanagar under Head of Account-0051 PSC.

(ii) 3 (three) copies of recent pass-port size photographs with self-attestation in the front side.

(iii) Attested copies of certificates and Marksheets of PG Degree/PG Diploma in Town Planning issued by the Assistant Registrar /Registrar/Controller of Examination /Vice-Chancellor of the concerned University to ascertain educational qualification.

Attested copy of Registration Certificate from Institute of Town Planning (India).

(iv) Attested copy of Matriculation Certificate for proof of age issued by the Board/University only will be accepted.

(v). Attested copy of APST certificate and copy of PRC in case of General Candidates.

(vi) All the supporting documents submitted by the candidates must be attested by a Gazetted Officer with proper designation, seal name and signature of the attesting officer otherwise the application will be rejected.

(vii) PWD candidates should submit disability certificate obtained from an authorized medical board. But such board should be comprised of a specialist of the particular disability for which the certificate is sought for failing which such certificate will be rejected.

N.B: The Application form should be procured in the name of the candidate only.

6. Last date for receipt of application.

The last date for receipt of application form by the Commission is up to 25-03-2011.

7. Other Rules:

- (i) The decision of the Commission as to the eligibility or otherwise of a candidate for admission to the Interview or Selection will be final and no correspondence or Personal enquiry will be entertained.
- (ii) Candidates already in service may apply direct to this Commission with NOC from his/her Head of Department.
- (iii) Application in the prescribed form along with necessary documents should reach this Commission in a Cover/Envelope superscribed "Application for the post of "Assistant Town Planner".
