**ADVERTISEMENT**

Applications in prescribed form are invited from the citizens of India for filling up 17 (seventeen) posts of Junior Specialist Doctors, under the Department of Health & Family Welfare, Govt. of Arunachal Pradesh in the following discipline in the pay of PB-3 Rs. 15,600-39,100/- plus Grade pay of Rs. 6600/- PM plus non-practicing allowances as admissible under rule. Out of 17 (seventeen) posts, 14 (fourteen) posts are reserved for APST candidate of which 1 (one) post is reserved for Orthopaedically Handicapped candidate, wherever it is applicable and 3 (three) posts are for open competition. The vacancy position is subject to variation.

**1. AVAILABILITY OF APPLICATION FORM :-**

Application form for admission to recruitment examination of the above post can be obtained from the Commission's office, Itanagar on all working days from 10 am to 4 PM upto **25/03/2011** on payment of Rs. 100/- only in cash.

**2. ELIGIBILITY :-**

- (i) Candidates must hold a recognized Medical Degree.
- (ii) Post Graduate Degree/Diploma in the concerned speciality.
- (iii) Working experience of 3(three) years for post graduate and 5(five) years for Diploma holder in a Govt. health institution or Govt. sponsored/recognized health institution is compulsory.

**3. AGE LIMIT :-**

Not exceeding 40 years as on **25/03/2011** (relaxable for Govt. servant by 5 years in accordance with instruction issued by State Govt.

**4. METHOD OF SELECTION :-**

The selection will be made through Viva-Voce Test/Interview only. However, if the number of applications received in response to the advertisement is large and it is not convenient or possible to interview all candidates, the Commission will restrict the number of candidates to reasonable limit on the basis of qualifications and experience higher than the minimum prescribed in the advertisement.

**5. HOW TO APPLY :-**

Along with the duly filled-up format, candidates must enclose the following documents otherwise the application will be rejected.

- (i) Treasury Challan of Rs. 20/- for APST, and Rs. 80/- for General candidates (Non-refundable) to be deposited in favour of the Secretary, AP PSC, Itanagar to be drawn at Itanagar under Head of Account- 0051- PSC.
- (ii) 3 (three) copies of recent color pass-port size photographs with self attestation in the front size.
- (iii) Attested copies of certificates and marksheets of PG Degree/Diploma in concerned speciality issued by the Assistant Registrar/Registrar/Controller of Examination/Vice-Chancellor of the concerned University to ascertain educational qualification.
- (iv) Attested copy of Registration from Medical Council of Arunachal Pradesh.
- (v) Experience certificate by the competent authority.
- (vi) Attested copy of Matriculation Certificate for proof of age issued by the Board only will be accepted.
- (viii) Attested copy of APST certificate and copy of PRC in case of General Candidates.
- (ix) All the supporting documents submitted by the candidates must be attested by a Gazetted Officer with proper designation, seal name and signature of the attesting officer otherwise the application will be rejected.
- (x) PWD candidates should submit disability certificate obtained from an authorized medical board. But such board should be comprised of a specialist of the particular category of disability for which the certificate is sought for failing which such certificate will be rejected.

**6. LAST DATE FOR RECEIPT OF APPLICATION :-**

The last date for receipt of application form by the Commission is **25/03/2011 upto 4 PM.**

**7. OTHER RULES :-**

- (i) The decision of the Commission as to the eligibility or otherwise of a candidate for admission to the interview or selection will be final and no correspondence or personal enquiry will be entertained.
- (ii) Candidates already in-service may apply direct to this Commission with NOC from his/her Head of Department.
- (iii) Application in the prescribed form along with necessary documents should reach this Commission in a cover/Envelope superscribed " Application for the post of Jr. Specialist (Discipline).

- (iv) **APPLICATION FORM OTHER THAN THE ONE PROCURED FROM THE ARUNACHAL PRADESH PUBLIC SERVICE COMMISSION, ITANAGAR WILL BE SUMMARILY REJECTED. NO DUPLICATE OR TYPED OUT FORM WILL BE ENTERTAINED.**
- (V) Application form not fulfilling the terms and conditions as stipulated in the advertisement will be rejected.
