**ADVERTISEMENT**

Applications in prescribed form are invited from citizens of India for filling up of 26 (twenty six) posts of Agriculture Development Officer, Group-A (Entry Grade) Agril. Service under the Department of Agriculture, Govt. of Arunachal Pradesh in the pay of PB 3 Rs. 15600-39100/- + Grade pay Rs. 5400/- PM plus other allowances as admissible to Arunachal Pradesh Govt. Employees from time to time. Out of 26 posts 21 (twenty one) posts are reserved for APST candidates, of which 1 (one) post is reserved for PWD candidates and 5 (five) posts are un-reserved for open competition. The category of disability eligible for PWD is for **One Leg and Hearing Handicapped**. Selection of candidates will be made on the basis of performances in the written examination and viva-voce test. Vacancy position and reservation is subject to variation.

**1. Availability of application form and Syllabus:-**

Application form along with the syllabus for admission to recruitment examination of the above post can be obtained from the Commission's office, Itanagar on all working days from **10 AM to 4 PM up to 26.07.2011** on payment of Rs. 100/- only.

**2 Eligibility**

The candidate must have attained the age of 21 years and must not have exceeded the age of 28 **years as on 01.01.2011**. However, the upper age limit is relaxable by 5 years in respect of APST candidates and another 5 years for being Arunachal Pradesh Govt. servant.

**4 Educational qualification**

Candidate for the post must hold a Bachelors Degree in Agriculture Science from any recognized University of India.

In respect of minimum educational qualification of the candidates, who have appeared at an examination passing of which would render them educationally qualified for Arunachal Pradesh Public Service Commission's examination but have not been informed of the results as also the candidates who intend to appear at such a qualifying examination shall also be eligible for admission to examination conducted by the Arunachal Pradesh Public Service Commission, provisionally.

Such candidates will be admitted to the examination, if otherwise, eligible but their admission shall be deemed to be provisional and subject to cancellation, if they do not produce the proof of having passed the requisite examination which are required to be submitted to the Commission by the candidates who qualify in written part of the examination prior to interview/viva-voce test. Their candidature will however be finally accepted on production of **PROOF OF HAVING PASSED THE QUALIFYING EXAMINATION IN ORIGINAL BEFORE THE DATE OF INTERVIEW SO FIXED BY THE COMMISSION FAILING WHICH THEY WILL NOT BE ALLOWED TO APPEAR**

should be produced as proof of having passed the qualifying examination and for the candidates of Autonomous Colleges, THE MARKSHEET /GRADE REPORT IN ORIGINAL issued by the Controller/Dy. Controller, Asstt. Controller/Chief controller of examination of such autonomous Universities shall only be accepted.

#### 5. Method of Selection

The eligible candidates will have to appear in written examination in the following subjects followed by viva-voce test to be conducted by the Arunachal Pradesh Public Service Commission at Itanagar on the basis of which selection will be finalized.

**The candidate who has secured a minimum of 33% or more marks in each written examination papers and has secured 45% of marks out of aggregate total marks in the written examination papers shall be eligible for viva-voce test.**

#### 6. How to Apply

Along with the duly filled-up format, candidates must enclose the following documents other wise the applications will be rejected.

- (i) Treasury Challan of Rs.20/-for APST, and Rs. 80/- for General candidates (Non-refundable) to be deposited in favour of the Secretary, AP PSC, Itanagar to be drawn at Itanagar under Head of Account-0051 PSC.
- (ii) 2(two) copies of recent pass-port size photographs with self-attestation in the front side.
- (iii) Attested copies of certificates and Marksheets issued by the Assistant Registrar/Registrar/Controller of Examination/Vice-Chancellor of the concerned University to ascertain educational qualification.
- (iv) Attested copy of Matriculation Certificate for proof of age issued by the Board/University only will be accepted.
- (v). Attested copy of APST certificate.
- (VI). Attested copy of PRC in case of General Candidates.
- (vii) All the documents submitted by the candidates must be attested by a Gazetted Officer with proper designation, seal and signature of attesting officer otherwise the application will be rejected.
- (viii) Physically Handicapped candidates should submit disability certificate obtained from an authorized Medical Board. But such board should be comprised of a specialist of the particular disability for which the certificate is sought failing which such certificate will be rejected.

**N.B: The Application form should be procured in the name of the candidate only.**

**8. Other Rules:**
